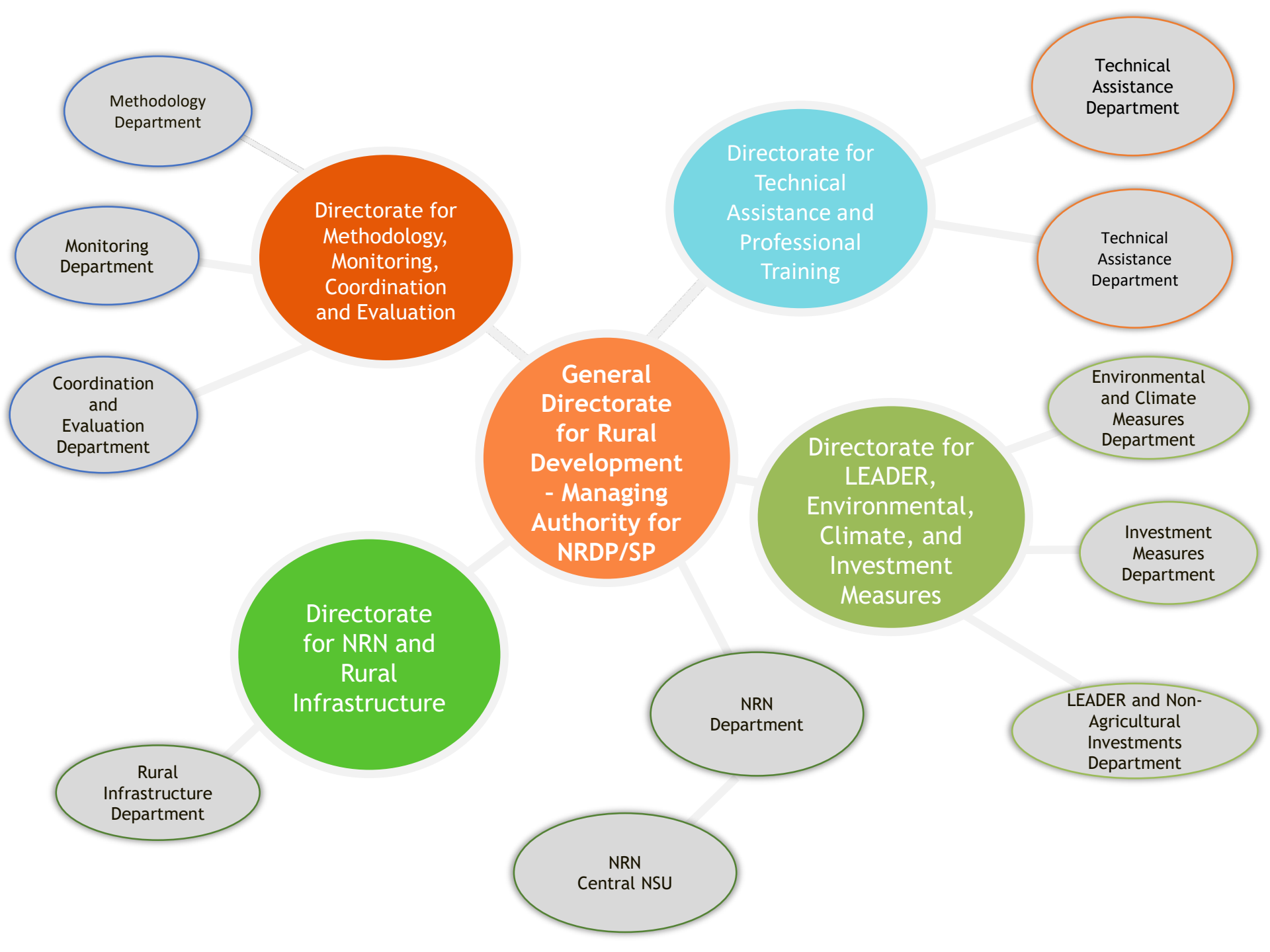

- **Pillar II: EAFRD** - Rural development policy



STRATEGIC PLAN'S BUDGET: 15.8 BILLION €

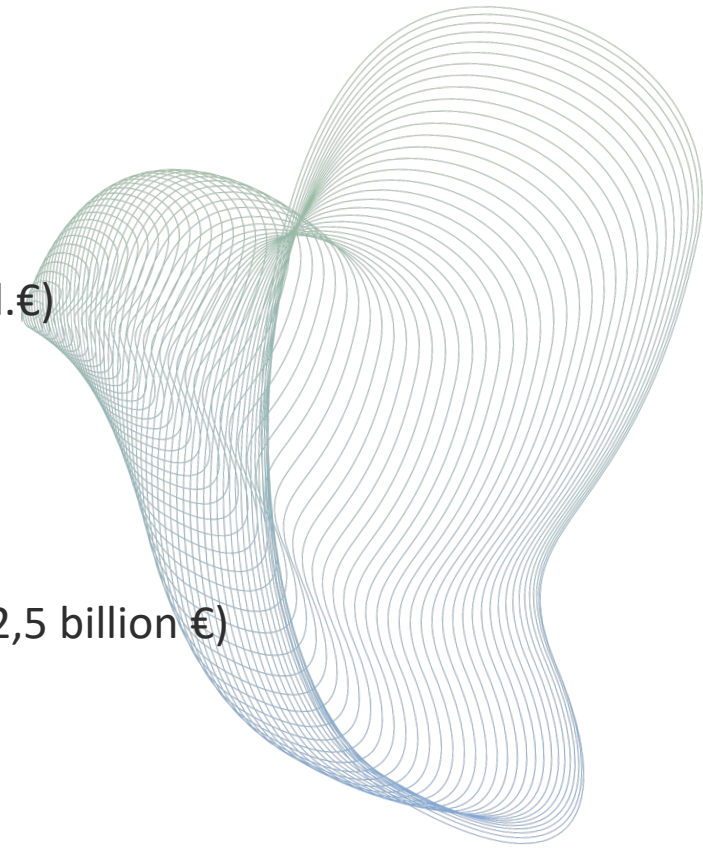

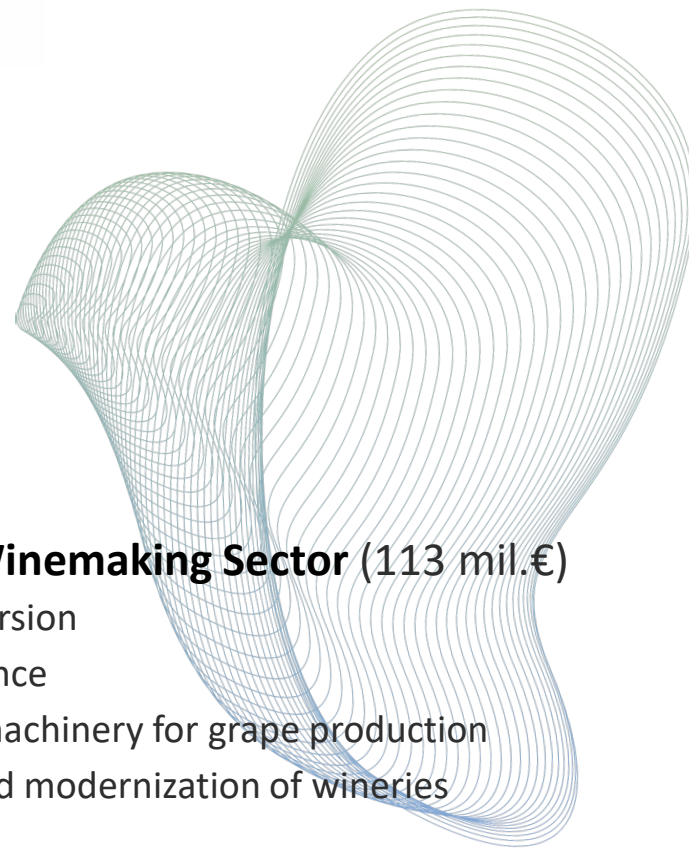

→ **Viticulture and Winemaking Sector** (113 mil.€)

- Vineyard reconversion

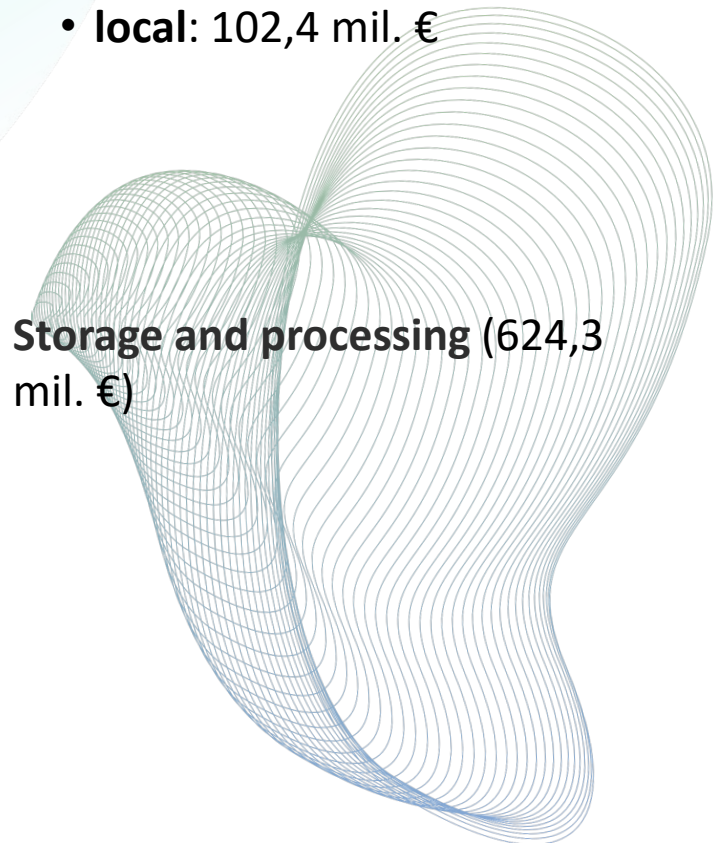

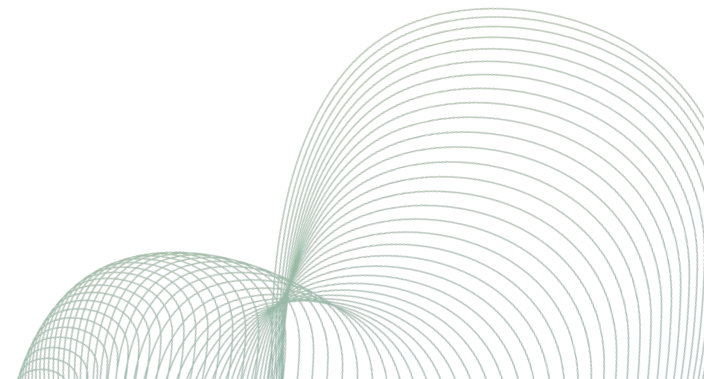

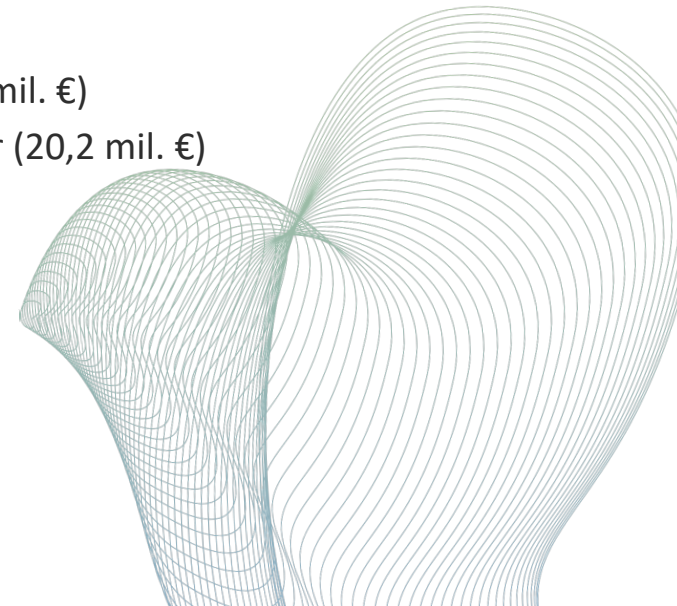

→ Development of rural areas (801 mil. €)

- **LEADER** (500 mil. €)
- **Road infrastructure** (301 mil. €)

→ Support interventions (338,3 mil.€)

- insurance premiums and instruments of risk management(97,9 mil. €)
- producer groups (15,4 mil. €)
- cooperation and innovation (20,0 mil. €)
- counseling and knowledge transfer (20,2 mil. €)
- Technical support (184,8 mil. €)



IMPLEMENTATION STAGE

EAFRD interventions

Auctioned allocation starting from November 2023: 1.9 billion. euro
(9 investment interventions and 1 professional training intervention)

- 8.040 submitted financing applications with a public amount of 3.5 billion. euro
 - 4.772 selected funding applications with public amount of 1.8 billion. euro
 - 3,795 contracts with a public amount of 0.7 billion. euro.
- 246 Local Development Strategies** selected with a value of 0.5 billion. euro
 - 2 Campaigns** (application years 2023 and 2024) for environmental, climate and animal welfare commitments financed (approx. 0.7 billion euros)
 - Payments made of 0.6 billion. euro (of which approx. 0.5 billion euro FEADR)

EAFRD absorption rate 10.40% (12.40% with pre-financing).

IMPLEMENTATION STAGE

FEGA interventions

- ✓ 2 Direct Payments Campaigns (application years 2023 and 2024) financed: approx. 1.9 billion. FEAGA euros/year
- ✓ Beekeeping sector - 2 years of application financed: approx. 6 million. FEAGA euros/year
- ✓ Wine sector – 2 interventions implemented
 - Restructuring and reconversion of wine plantations: projects of approx. 45 million euros, payments made of 8 million. euro
 - Harvest insurance: approx. 1 mil. euros/year
- ✓ Vegetable-fruit sector: 4 Operational Programs approved with a total support value of approx. 5 million. Euros. No payments have been made
