Evaluation Plan of the CAP SP of Spain



The Evaluation Plan of the CAP SP of Spain was carried out by the Ministry of Agriculture, Fisheries and Food with the involvement of the regions and the Monitoring Committee.

>It was prepared on 31st of july of 2023 and the Monitoring Committee gave its opinion in August, 2023.

Assessment about the effectiveness of the procedures and Implementation steps. That is, whether the CAP SP has been applied as it was set out, achieving certain results, and taking into account the Implementation mechanisms and the interventions.

Assessment of the **progress towards the objectives taking into account the most immediate results** (financial execution, interventions, achievements) Assessment of the achievements and the contribution to the CAP objectives.

These evaluations will include an analysis to determine the casualty between interventions and impact towards the objectives. As far as possible, the net contribution of the CAP SP will be determined thanks to the impact indicators, or, if there isn't available data, proxies Will be applied (indirect estimators)


